Makralog is committed to protecting your privacy. This privacy statement explains data collection and use practices of the Makralog website [www.makralog.com](http://www.makralog.com). By accessing the Makralog site, you are consenting to the information collection and use practices described in this privacy statement.

### **Collection of your Personal Information**

We will ask you when we need information that personally identifies you (personal information) or allows us to contact you to provide a service or that you have requested information such as receiving information about Makralog products and services, ordering e-mail newsletters.

The personal information we collect may include your name, title, company or organization name, work/personal e-mail, work/personal phone, work or home address, information about your job function, information about your company, information about your visit, such as the name of the Internet service provider and the Internet Protocol (IP) address through which you access the Internet; the date and time you access the Makralog site; the pages that you access while at the Makralog site and the Internet address of the Web site from which you linked directly to our site; information about the geolocation; other information entered by the user into such form as specified by the Makralog.
